Senator Maurice Washington has built a record of selling out Nevada's children, seniors and women to help tobacco companies, big out-of-state insurance corporations and international drug manufacturers – the same corporate special interests that have financed his political career for 10 years.

**WASHINGTON'S SELLOUTS
TO HIS CORPORATE CONTRIBUTORS
ARE ALL ON THE RECORD.**

- Washington took thousands of dollars in corporate campaign contributions from tobacco companies over the years (Official State of Nevada Campaign Contributions & Expenses Reports, 1996-2004), then voted against legislation to use tobacco settlement money for Millennium Scholarships to help Nevada's children get a better education (AB 667 and SB 496 – Official Nevada State Senate Legislative Voting Records).
- Washington took \$10,700 from big drug companies in 2002 (Official State of Nevada Campaign Contributions & Expenses Reports, 2002), then voted against a law allowing Nevada seniors to buy discount prescription drugs from Canada. Washington's vote against SB 5 protected the profits of his corporate special-interest contributors, but not the interests of northern Nevada seniors on fixed incomes.
- Washington took \$5,450 in campaign contributions from insurance companies (Official State of Nevada Campaign Contributions & Expenses Reports, 2002), then voted against requiring those insurance companies to provide key coverage for Nevada women suffering from breast cancer. Washington's vote against AB 60 favored the interests of his political backers at the expense of Nevada's wives, mothers, sisters and daughters.
